Trustees' Annual Report - year ended 31 December 2022

Structure, governance and management

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form), Recruitment and Appointment of Trustees.

Members of the Kirk Session are the charity trustees. The Kirk Session members are Elders of the Church and are chosen from those members of the Church who are considered to have the appropriate gifts and skills. The Minister, who is a member of the Kirk Session, is elected by the Congregation and inducted by Presbytery.

We have begun to form small groups to help develop and apply our mission in particular areas. The first group to be formed is the Pastoral Care Group They have worked with the Minister and Kirk Session to support the congregation during 2020.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Perth Riverside Church of Scotland is a Christian community based in north Perth.

As a church we seek to fulfil our mission, aims and values through regular Christians worship, community activities and service to our parish.

Achievements and Performance

Attendance

Over the last year our attendances have returned to pre-covid levels. We have seen several new individuals and families join our community.

Overview of 2022 at Riverside

Services & Small Groups

Our services have been relatively well attended and we have resumed the breakfast service on the last Sunday of each month. We have also begun to meet on Sunday evenings for Bible study and our house groups have resumed to meet in person with one group continuing to meet online.

Community Work

Our Cafe, Martha's Kitchen, has been open since March 2022, it provides food and drinks to people from our neighbourhood and beyond. We have also been able to provide volunteer opportunities and internships in the cafe. The 'Let's not waste it' project provides weekly meals to carers in collaboration with PKAVS. We have also operated as a warm space and recently received a small grant towards this. Our building is let daily, offering space to local organisations and businesses. An Architect firm has been engaged to design the community/church space at Bertha Park. At both Riverside and Bertha Park we are currently collaborating with other community organisations to support young people and families.

Church Life

Our congregation meets weekly for worship on both Sunday morning and evening. Throughout the week we continue to meet in small groups in homes and in the church building. Our gardening and 'Knit and Natter' groups meet regularly. In collaboration with the cafe team we have held several community outreach activities and our annual community event 'The Nativity Experience' was again a great success.

Financial Review

Riverside recorded a deficit of £19,632 in 2022, following 2021's surplus of £6,476. However, these figures are somewhat misleading because Riverside provides supervisory, administrative and accounting support to the Bertha Park project. The Bertha Park restricted funds form part of our accounts, and in 2021 they showed a surplus of £15,369. Riverside Church cannot touch this money. Excluding the Bertha Park money from our accounts we would have recorded a 2021 deficit of £8,893 and a 2022 deficit of £18,299.

We have transferred significant amounts of money in both directions between unrestricted funds and restricted funds, in agreement with the relevant bodies. This has been to pay for the set up of the Martha's Kitchen project, and also to reflect money spent in accordance with the reduction we were granted in our Church of Scotland Ministries and Mission Allocation payment. This necessary practice of transfers has exposed a weakness in the design of our accounting system, which was never intended to handle such complications. The system will be redesigned as a matter of priority in 2023.

The best basis for a comparison in our financial performance is the unrestricted funds deficit before transfers. This improved slightly from £11,365 to £10,196. This remains an unsustainable position.

After giving declined by 10% in 2021 we saw an increase of 17% in 2022 (excluding legacies and donations to Bertha Park). We also saw an increase in income from hall rentals of £10,700 (more than three fold). The 2021 figure was badly affected by Covid lockdown. A more useful comparison is with 2019 and 2022 is 42% higher. Martha's Kitchen also began to generate money, bringing in a net figure of £2,157.

The overall picture is still very challenging. The unrestricted fund balances are extremely low and we will be unable to meet any significant expenditure on the building or manse without fundraising or support from the Church of Scotland. We are still heavily dependent on relatively few families. As noted last year the newer, and younger, people who have joined us tend not to have as much disposable income.

Reserves Policy

The reserves figure is a notional item that does not appear in the accounts. It reflects the amount of money we believe we should hold in the bank as a precaution. Our policy has been to hold reserves of £25,000. However, we no longer have sufficient unrestricted funds to meet this reserving target. Our fund balances are currently £23,428 (setting aside Bertha Park money), of which £16,549 is in restricted funds.


Statement of Trustees 'Responsibilities

They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Perth Riverside Church of Scotland

I report on the accounts of the charity for the year ended 31st December 2020 which are set out on pages 6-11.

Respective responsibilities of trustees and examiner

The Charity Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustees Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The Charity Trustees consider that the audit requirement of Regulation 10 (1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with regulation 11 of the Charities Accounts (Scotland) Regulations 2006 (as amended). An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

The two sets of figures are reconciled by the net expenses/income that was not cleared at the start and end of the year. If the reconciliations match then the discrepancy figure is zero. There is a positive figure for 'expenses incurred but not paid/cleared' because we overpaid our MMA charge by £2,442. The Church of Scotland agreed to repay that. The money was received in January 2023.

1 Trustee Remuneration and Related Party Transactions

Purposes of Designated Funds

The Fabric Fund was established for the maintenance of the church building. It was set up in 2011. Expenditure categorised as "repairs and other Fabric Fund expenditure", or as "manse fabric" comes out of this fund.

The Boiler Fund was set up in 2020 for the replacement and ongoing repair of the central heating boiler.

The Youth Work Fund was established to provide support for Riverside's mission work with local youth.

The Community Work fund was set up in 2018 with a legacy and is intended for community work. The transfers from this fund were to cover expenditure that was paid for out of the fund.

The Mission Fund exists to ensure that we have money set aside for our core purpose of sharing the good news of God's love. It was set up in 2011. Expenditure categorised as "Mission" or "Outreach" comes out of this fund.

The Gardening Group fund was set up at the request of members of the congregation to hold money from plants that they sold and which would be used for expenditure on the garden. This complicated the accounting and is one of the reasons that the system will be redesigned.

Let's Not Waste It was set up in 2022 to hold grant money for a community project that does not qualify as a restricted fund.

The children's outings fund was set up in 2015 following a gift from the family of Matt McKean, a member who died in 2010. Matt's family wanted the money to be used for some form of childrens' outing. The trustees have full discretion over how this money will be used.

The Designated Donations fund was created to hold money that has been raised with the express intention of donating it to an external charity. The exact destination is at the discretion of the Kirk Session, so it cannot be a Restricted Fund.

Purposes of Restricted Funds

Restricted Fund #1 (youth work) holds the remainder of the money that was raised between 2004 and 2006 to pay the salary of a youth worker. She resigned before the end of her contract and a replacement was not appointed. The youth worker post was managed by Perth Riverside Church and Perth YMCA as a joint project, committed to Christian youth work in Riverside's parish. This money is assigned to a restricted fund because it can be spent only on projects that are approved by both Riverside and Perth YMCA. That is why it is held in a separate fund from the general Youth Work Fund, which can be spent at the discretion of the trustees.

Restricted fund #2 Mission (MMA reduction) was set up to allow us to account to the Church of Scotland for spending money that they provided by reducing our MMA payment, subject to certain conditions.

The Martha's Kitchen and Audio Visual funds were set up to allow us to account to grant providers. We must be able to show that we have spent the grants appropriately.

The Bertha Park funds are held in our bank accounts, but they are not Riverside's money.

5 Minister's Stipend

All Church of Scotland congregations contribute towards the National Stipend Fund, which bears the costs of all ministers' stipends and employer's contributions for National Insurance, pensions and the Housing and Loan Fund. Ministers' stipends are paid in accordance with the National Stipend Scale, which is related to the years of service. For 2022 the minimum stipend was £28,700 and the maximum stipend (in the 5^{th} and subsequent years) £35,269.

6 Collections for Third Parties

The church did not make any collections for third parties.
